

# Sedgefield Hunter Pace

April 21, 2024- rain date April 28, 2024



**ENTRY FEES per individual:** Adults \$50 Juniors (under 18) \$40

**LOCATION:** Highgrounds. Willow Trail, Sutherlin VA, just east of Cloverdale Quarters Wedding Event Center on north side of Highway 58.

**TIME:** Trailers may arrive starting at 8:30 am First riders on course at 9:00 am; last riders must start by 1:30 & complete by 3:00 pm.

## Divisions:

**Strollers:** A relaxed meander through the country. Pace 4 MPH. No jumps.

**Hill Topper:** For sporty riders liking a moderate pace through the country. Jumps are optional. Pace 6 MPH.

**First Flight:** For riders who enjoy faster and challenging ride. Jumps are optional. Pace 8 MPH.

**Full Cry:** For the adrenaline junkies! Jumps are encouraged but are optional. Pace is 10 MPH.

There is no required dress code (or tack requirements), but we do request that all riders wear protective riding helmets. No timing devices allowed. **A current negative Coggins is required for all horses.**

Please be aware that there is no water for your horses available on-site. Bring your own water!

Prizes for 1st-6th places are awarded for each division (ribbons will be mailed to Rider #1 on the entry form). This pace is run in conjunction with the Red Mountain Hounds series and placings may contribute to year end awards.
